ART.1: ORGANIZATION

A.S.D. PRO GORIZIA ORGANIZES AN INTERNATIONAL TRIANGULAR TOURNAMENT ENTITLED "3° MEMORIAL "GIANCARLO POZZO" – CALCIO FEMMINILE", THAT WILL TAKE PLACE ON 01^h SEPTEMBER 2018 AT 4:30 P.M. IN GORIZIA "STADIO ENZO BEARZOT

ART.2: CATEGORY OF PARTICIPATION AND AGE LIMITS

THE TRIANGULAR IS RESERVED TO SOCCER PLAYERS BELONGING TO THE CATEGORY "FRIST TEAM" REGULARLY ENROLLED WITH HER OWN SOCIETY AND NATION FOR THE SEASON IN PROGRESS.

ART.3: LOANS

LOANS ARE NOT ALLOWED.

ART.4: FOOTBALL PLAYERS LIST

A LIST OF PLAYERS ELIGIBLE TO PARTICIPATE SHALL BE PRODUCED TO THE ORGANIZER COMMITTEE BEFORE THE START OF THE COMPETITION, THE LIST MUST INCLUDE A MAXIMUM OF 20 PLAYERS. ONCE THE LISTS HAVE BEEN DELIVERED TO THE ORGANIZER COMMITTEE, THEY CAN NOT BE CHANGED.

THE LIST OF PLAYERS FOR TEAM, THAT SHALL BE PRODUCED FOR THE REFEREE IS LIMITED TO 18 PLAYERS.

ART.5: SUBSTITUTION

SUBSTITUTIONS ARE ALLOWED IN NUMBER OF 5 AT ANY TIME OF THE MATCH AND INDIPENDENTLY FROM THE ROLE OF THE PLAYERS.

ART.6: PARTICIPATING TEAMS

THE TEAMS THAT WILL TAKE PART AT THE TOURNAMENT ARE:

UPC TAVAGNACCO CALCIO (ITALIA)
Z.N.K. MOJE – LECE.SI RADOMIJE (SLOVENIA)
RAPPRESENTATIVA DELLA CARINZIA (AUSTRIA)

ART.7 TOURNAMENT FORMULA

THE TRIANGULAR IS CARRIED OUT OF THREE MATHCHES OF 40' IN SUCCESSION AS IN FOLLOWS:

1ST MATCH TEAM A AGAINST TEAM B
2ND MATCH TEAM C AGAIST LOOSER 1ST MATCH
3RD MATCH TEAM C AGAINST WINNER 1ST MATCH

THE TEAMS TO PLAY WILL BE PICKED BY LOT BETWEEN THE PARTICIPANT TEAMS BY THE ORGANISATION.

ART. 8 RANKING

THE RANKING WILL BE DRAWN UP IN LIGHT OF THE FOLLOWING CRITERIA:

1. 3 POINTS FOR WIN IN REGULAR TIME
2. 2 POINTS FOR WIN IN PENALTIES
3. 1 POINT FOR DEFEAT IN PENALTIES
4. 0 POINT FOR DEFEAT IN REGULAR TIME

IN CASE OF EQUAL POINTS APPLY THE CRITERIA IN ORDER LISTED: OUTCOME OF DIRECT GAMES; DIFFERENCE NETS; ONLY IN STILL EQUAL DRAWING ON THE MATCH FIELD.

ART.9 HALVES OF GAMES

THE MATCHES OF 40 MINUTI WILL TAKE PLACE IN 2 (TWO) TIMES OF 20 MINUTES EACH. FIVE MINUTES WILL LEFT TO CANGE THE FIELD END THE PLAYERS.

MATCHES ARE PLAYED 11 VS 11 REGULAR FOOTBALL FIELD WITH REGULAR DOOR AND NUMBER BALLS FIVE.

ART.10 PENALTY

IN CASE OF DRAW AFTER THE END OF TIME REGULATION (40' MINUTES).

ART. 11 EXTRA TIME

UNSCHEDULED.

ART.12 REFEREES

THE MATCHES WILL BE DIRECTED BY REFEREES F.I.G.C. / A.I.A.

ART. 13 TOURNAMENT COMMITTEE

THE TOURNAMENT COMMITTEE WILL BE IN CHARGE OF EVERY QUARELL, PROTEST, COMPLAINT AND ANY OTHER UNFORESEEN CIRCUMSTANCE. MEMBERS OF THE COMMITTEE ARE:

- GIULIO MOSETTI V.PRESIDENT
- ROBERTO RE MEMBER
- DOMINGO BIANCO MEMBER

THE COMMITTEE WILL NOT ACCEPT ANY PROTEST OR COMPLAINT ABOUT REFEREE DECISIONS. WHEN NECESSARY THE COMMITTEE WILL SEND A REPORT TO THE NATIONAL FEDARATION. MISCONDUCT OF PLAYERS WILL BE SIGNALLED TO THEY OWN FEDERATION, WHICH WILL TAKE THE MORE APPROPRIATE FINAL DECISON.

ART.14 DISCIPLINE OF THE TOURNAMENT

THE TOURNAMENT REGULATION WILL BE GRANTED BY THE REGULAR/SUPPLY ARBITRATOR OF THE GORIZIA REGIONAL COMMITTEE. TEAMS WITH UNREGULAR PLAYERS WILL BE BARRED FROM THE COMPETITION.

ART.15 IMMEDIACY OF SANCTIONS (FOR THE TOURNAMENT OF RAPID DEVELOPMENT)

THE IMMEDIACY OF SANCTIONS IS PROVIDED BY REGULATIONS AS FOLLOWS: A PLAYER SENT OFF DURING A GAME WILL NOT PARTECIPATE TO THE FOLLOWING MATCH AND TO THE PENALTIES.
