REGOLAMENTO

ART. 1 ORGANIZATION

The A.S.D. PRO GORIZIA in collaboration with the A.S.D. International Tournament City of Gradisca - Nereo Rocco Trophy, indicate and organize the thirty-sixth edition of the "City of Gradisca" International Tournament which will be held from 1 to 7 September 2022 in Gradisca d'Isonzo and on other fields of the Friuli Venezia Giulia Region.

ART. 2 CATEGORY OF PARTICIPATION AND AGE LIMITS

The tournament is reserved for players of the U18 category, duly registered with their own club and federation for the current season, born from 01.01.2005 to the age of 15.

ART. 3 LOANS

The use of non-interchangeable loans in a maximum number of 3 (three) per team is allowed and valid for the entire duration of the tournament, upon presentation of a regular permit issued by the company to which they belong, which cannot be among the participants in the tournament.

ART. 4 LIST OF PLAYERS

The participating clubs must submit to the Organization of the Tournament, before its start, the list of players they intend to use up to a maximum of 20 and the relative number of the jersey they will wear for the duration of the Tournament. After delivery, it is forbidden to make any changes.

Up to a maximum of 20 players will be indicated in the list to be presented to the referee before each match.

ART. 5 REPLACEMENTS

7 substitutions are allowed, regardless of the role, at any time during the match.

ART. 7 TOURNMENT FORMULA AND RANKINGS

The 8 teams participating in the Nereo Rocco Trophy, reserved for Club teams, will be divided, following a draw, into 2 groups of 4 teams each, and will compete in the preliminary round with the Italian formula. The first 2 classified of each group will play the semifinals (first vs second and the winners the semifinals will play the final.

ART. 8 RANKINGS

The rankings will be drawn up on the basis of the following criteria:

3 points for a win - 1 point for a draw - 0 points for a defeat. In the event of a tie, the criteria listed below apply:

- 1) outcome of direct meetings
- 2) goal difference in direct matches between teams with equal points
- 3) higher number of goals scored on the total of direct matches between teams with equal points
- 4) goal difference on the total number of matches played in the group
- 5) higher number of goals scored on the total number of matches played in the group
- 6) fewer disciplinary sanctions
- 7) draw.

ART. 9 MATCH TIMES

The competitions will take place in two halves lasting 45 minutes each.

The matches are played 11 against 11 on regulation fields, with regulation goals and with balls n. 5.

ART. 10 PENALTY

For all matches in the event of a tie at the end of regular time, the winner will be designated by means of penalty kicks to be carried out according to the rules established by rule 14 of the rules of the game and official decisions.

ART. 11 OVERTIMES

There is no extra time.

ART. 12 REFREES

The matches will be directed by referees of the F.I.G.C. / A.I.A.

ART. 13 TOURNMENT COMMITTEE

A Tournament Committee will be set up which will be responsible for any dispute, protest, complaint or unforeseen circumstance. The Committee will consist of the following people:

The committee will not accept protests or complaints about the decisions made by the referees. The committee will report to its national or international federation in charge of adopting the appropriate measures, every player and every member of the participating delegations found guilty of unsportsmanlike conduct during the tournament.

ART. 14 TOURNMENT DISCIPLINE

The discipline of the Tournament is entrusted to the Sporting Judge, holder or alternate of the Provincial FIGC delegation of Gorizia.

ART. 15 AUTOMATION OF PENALTIES

In consideration of the fast-paced nature of the tournament, the player who is in any case expelled during a match will not be able to participate in the next match except for greater penalties imposed by the Sports Judge.

The player who incurs a SECOND ADMONITION during the tournament will be disqualified for a match following a declaration by the Sports Judge.

ART. 16 COMPLAINTS

Any complaints must be presented by hand to the referee within 30 (thirty) minutes from the conclusion of the match to which they refer, together with the complaint fee of Euro 52.00- (Euro fifty-two / 00-); a copy of the complaint must be delivered to the counterpart always within 30 minutes.

ART. 17 INSURANCE

It is the responsibility of each participating club to insure their players insurance coverage. The organization of the Tournament is responsible for the regularity of the insurance coverage.

ART. 18 I.F.A.B.

Matches are played according to the rules of the International Football Association Board (IFAB) current edition.

ART. 19 GENERAL RULES

The organizing company undertakes to bring to the attention of the participating companies, before the start of the tournament, the regulations themselves in the form approved by the Federal Bodies.

- greeting
- The managers and technicians of the companies participating in the tournament must ensure that, both at the beginning and at the end of each confrontation, the participants greet the public and greet each other.
- waiting time
- The teams must appear on the pitch in their uniforms within 15 minutes of the fixed time.
- suspension of a match
- In the elimination phase, in case of suspension of a match due to impracticability of the field, the result obtained up to the moment of the final suspension of the match will be valid, while in the final phase, if the two teams are on the same result, will proceed to the draw in the presence of the referee and the captains of the two teams.
- failure to start a race

In case of failure to start a match due to force majeure, not due to the negligence of one of the two teams, the draw will take place and the winner will be assigned the result of 3 - 0.
